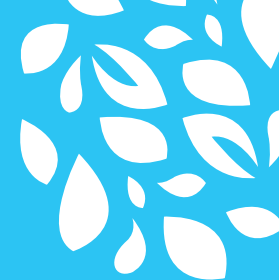


# ESG Manager Course
